Toxfree Shareholders Approve Scheme of Arrangement

At the Scheme Meeting of Tox Free Solutions Limited ("Toxfree") held in Perth today, Toxfree shareholders voted in favour of the scheme of arrangement under which Cleanaway Waste Management Limited will acquire 100% of the ordinary shares in Toxfree via its wholly-owned subsidiary, Cleanaway (No. 1) Pty Ltd ("Scheme").

Toxfree advises that the resolution to approve the Scheme was passed by the requisite majorities of shareholders, with:

- 99.18% of Toxfree shareholders present and voting (either in person or by proxy) in favour of the resolution; and
- 99.94% of votes cast in favour of the resolution.

Next Steps and Indicative Timetable

Toxfree will seek approval for the Scheme from the Federal Court of Australia ("Court") at a hearing scheduled for 9.00 am on Thursday, 10 May 2018 (Perth time).

If the Court approves the Scheme, Toxfree intends to lodge the orders of the Court with the Australian Securities and Investments Commission ("ASIC") on Friday, 11 May 2018. Once this occurs, the Scheme will become effective and it is expected that Toxfree shares will be suspended from trading on the ASX with effect from the close of trading on Friday, 11 May 2018.

Scheme Consideration

If the Scheme is implemented, Toxfree shareholders who are registered as such on the Special Dividend Record Date and the Scheme Record Date will receive a total cash payment of \$3.425 for each Toxfree share that they own, which will comprise:

- a fully franked Special Dividend of \$0.58 per share; and
- Scheme Consideration of \$2.845 per share.
