Transpacific is Australia's leading recycling, waste management and industrial services company. Cleanaway, a subsidiary company of Transpacific, owns and manages a number of waste processing operations, including advanced waste treatment facilities, transfer stations, resource recovery and recycling facilities.

We are writing to inform you of our proposal to establish and operate a waste transfer station at the rear of 6 Noble Street, Kewdale.

A waste transfer station provides a drop-off point for waste collected from around the city, enabling consolidation and efficient transport to a licensed waste management facility outside the metropolitan area. Details of our proposed waste transfer station operation in Kewdale are provided on the next page.

Approvals are required from the City of Belmont and the Department of Environment Regulation before the operation can proceed.

We seek your feedback on our proposal and welcome discussion with you on any issues or concerns you may have regarding the proposed facility.

We envisage submitting our application for approval in early July and would appreciate your initial feedback by 3 July 2015, however you will have an opportunity to provide input after this date.

Proposed Waste Transfer Station

6 Noble Street Kewdale



Cleanaway is proposing to establish and operate a waste transfer station at the rear of 6 Noble Street.

The waste transfer station will operate 24 hours, 7 days a week within an existing enclosed building at the rear of 6 Noble Street, Kewdale.

Commercial waste and municipal solid waste will be transported to the site by waste collection vehicles. These vehicles will enter the site from Noble Street and pass over a weighbridge before turning around in front of the transfer building and reversing through one of three roller-shuttered entrances. Vehicles will discharge their waste onto the tipping floor and then drive out of the building, exiting the site onto Noble Street.

A front-end loader will push up or temporarily stockpile waste between deliveries and shift waste from stockpiles onto a conveyor which feeds a compactor. The compactor will progressively load waste into an enclosed waste transfer trailer connected to the compactor. The waste transfer trailers will then be hauled to Cleanaway's licensed waste management facility near Dardanup, south of Perth.

We recognise the potential environmental impacts (e.g. odour and noise) associated with these types of facilities and have put in place management measures to avoid impacts and disturbance to neighbours and the local community.

Potential odour and noise emissions have been carefully considered in design and operational planning and detailed modelling studies have been undertaken to ensure there will be no adverse impacts for surrounding land owners, and all relevant environmental standards will be met.

Examples of measures to be implemented include:

- Construction works will only occur between the hours of 0700 - 1700 on weekdays, and 0700 and 1430 on Saturdays.
- Waste will be transferred within 24 hours of arrival at the waste transfer station and the total volume of waste on the floor will be strictly controlled.
- Maximum of three doors of the station will be open at any given time during the day.
- Maximum of one door will be open at any given time during the night.
- All doors will be fast-closing.
- Regular building floor and stockpile inspections for vermin.
- A very high standard of housekeeping will be maintained at all times including regular cleaning of equipment, immediate pick up of any litter or spilled waste and regular cleaning of the tipping floor.
- Frequent litter inspections, monitoring of odours and noise by staff and ongoing management program to prevent any adverse impacts on the amenity of surrounding properties.
